- Must be 18 years of age to participate.
  - No names or initials may appear on the board until payment is made.
  - Payment must be in **cash**. No credit allowed.
  - All spaces must be sold before randomly assigning numbers 0-9 to vertical & horizontal axis.
- All unsold spaces must be purchased by the sponsor and marked accordingly.
- All winners must be clearly identified on the board and full names listed on back.
- Sports pool cards must be retained by sponsor for at least 90 days from date of the event.
- See back for additional rules.

### ADDITIONAL SPORTS POOL RULES

Before you start, include the applicable information on the sports pool card:

1. The name of the **sports event** or series of events.
2. The name of the **competitors** either in the sports event or series of events. (ie: Detroit vs. Minnesota, Home and Away/Visitor).
3. The **date(s)** of the sports event or series.
4. Total number of **chances** available (25, 50, or 100 squares, *etc.*).
5. The **cost** to participate for each chance (space) per sports event. (Cost or “price” can be \$1 - \$100 and must all be the same within each board.)
6. The total amount to be **paid** to each winner(s) and/or what prizes the winner(s) will receive. *Prizes cannot exceed \$2,500 per event.* If a board pays both ways, it must be advertised in advance of sales.
7. Payouts for predetermined **intervals**, if any.
8. Name of the person or **business** conducting the sports pool (e.g., Bob’s Casino).

Once you **start selling spaces**, you may not cancel or alter the board in any manner. The board will need to include:

9. Name (or initials) of **participants** who purchased chances on the board. (Space must be paid for before a participant’s name or initials are allowed on the board.)
10. **ALL SPACES must be sold to participants** and any remaining spaces **prior to start** of the game (event) must be purchased by the board sponsor. Those spaces must clearly show they were bought by the sponsor.
11. All money must be maintained separately for each board

When **all spaces are sold**, don’t forget:

12. **NUMBERS** will need to be randomly chosen and placed on the board before start of game.
13. **TEAMS** are assigned to vertical and horizontal axis before start of game.
14. **If the sports event is cancelled**, the person conducting the sports pool must refund the full amount of the purchase price to each participant. **If the event is rescheduled**, the board sponsor has two options: a) return money back to participants or b) change the board to reflect the new date of the sports event. Boards that do not sell all their spaces cannot be changed to a new date or sports event. Those spaces have to be purchased by the sponsor prior to the advertised sports event.

After the Sports Event:

15. **WINNERS** of each prize must be identified on each board.
16. All sports pool cards must be kept for 90 days minimum after the event or last event in a series.
