2020 MONTANA MEDICAL EXAMINER'S REPORT April 30, 2021



OVERVIEW:

The Montana Medical Examiner's Office (MTMEO) is a bureau within the Montana Department of Justice, Forensic Science Division. It was created in 1980 to provide death investigation resources for county coroners, law enforcement agencies, and county attorneys on behalf of Montana's citizens. Montana is the fourth largest state in the United States, encompassing 147,040 square miles, and has an estimated population of 1,068,778 for 2019. This report summarizes the statistical results of the MTMEO cases performed during the 2020 calendar year.

OUR VISION STATEMENT:

We strive to create a partnership between Medical Examiners and Coroners to promote the health, well-being, and safety of the citizens of Montana through education, service, and compassionate, professional death investigation.

RECENT PROJECTS COMPLETED:

The Montana Medical Examiner's office recently completed the following projects and goals:

- Implementation of a Statewide death investigation database, ImageTrend, with the assistance of the State's Department of Health and Human Services
- Creation of standard operating procedures for the MTMEO
- Application for NAME accreditation in September 2020; awarded provisional status pending an on-site visit in 2021

CURRENT PROJECTS:

The Montana Medical Examiner's office is currently focused on the following projects and goals:

- Continue to train coroners and increase usage of ImageTrend, the Statewide death investigation database.
- Actively promote opportunities to continuously improve death investigation and establish more uniform practices among the counties.
- Attain full accreditation through the National Association of Medical Examiners (NAME) pending on site visit in June 2021.
- Partner in the National Center on Forensics grant through NIJ along with George Mason University, the American Society of Clinical Pathologists, and the National Association of Attorney Generals, which includes establishing a Coroner Liaison position and providing training for medical and pathology students.

SUMMARY OF 2020:

In 2020 the Montana Medical Examiner's Office employed four forensic pathologists, two autopsy assistants, and three part-time autopsy assistants. Administrative support was provided by the Forensic Science Division. Two pathologists work at the State crime laboratory in Missoula to serve the needs of coroners in western Montana. Two pathologists work at the State morgue facility in Billings to serve the needs of coroners in Eastern Montana. During calendar year 2020 a total of 747 postmortem examinations were performed (Missoula 420, Billings 327). Our pathologists responded to a limited number of scene investigations and recoveries. We provided court testimony and made educational presentations at the annual Montana Coroner Advanced and Basic Coroner trainings. Informational meetings took place with coroners, law enforcement, county attorneys, organ and tissue procurement agencies, and funeral directors. Our chief medical examiner also collaborated with the Montana Department of Emergency Services in developing a COVID-19 response plan, which was submitted to the Governor's Office.

Casework activity increased 13.7% in 2020 from 2019. As with similar trends across the country during the COVID19 pandemic, we experienced a significant increase in activity. We had 69 cases that involved COVID19 status inquiries, of which 18 were confirmed positive. Homicides increased substantially over prior years (see tables below), and we had 31 cases considered in custody deaths, which involve either inmates or deaths occurring in presence of law enforcement.

In September 2020, the MTMEO applied for accreditation for the first time through the National Association of Medical Examiners (NAME). It was awarded provisional status pending site visits in June 2021.

Based on recommendations that appear in the Scientific Working Group on Medicolegal Death Investigation (SWGMDI) "an autopsy rate of one per 1000 population might be considered as a best-case scenario formula for ensuring that medicolegal autopsies are performed in numbers that need public health, public safety, justice system, medical quality assurance and other needs." Generally, the need for a postmortem examination (autopsy) in Montana is determined by the county coroner per Title 46, Chapter 4, Part 1 of Montana Code Annotated. NAME inspection data for all offices published in the SWGMDI 2013 report listed an average autopsy rate of 0.5 per 1,000 persons for offices of all types and 0.7 per 1,000 persons in facility surveys. Utilizing our current data, the autopsy rate per 1,000 population in Montana is 6.3% across all counties (2019). Some counties meet or exceed the 1.0 per 1,000 population recommendations

while some counties are below the recommendations. Results by county are listed in Total Autopsies by County table beginning on page 3.

Montana death investigations are served through a county coroner system with support by the State Medical Examiner's office. The following statistical information represents *only* those cases that coroners delivered for autopsy or examination and cannot encompass all deaths in the State. At the discretion of county coroners, selected suicides, overdoses, traffic fatalities, and well-established natural deaths are not submitted for autopsy.

TOTAL AUTOPSIES BY COUNTY:

Montana consists of 56 counties. Approximately 2/3 of the population resides in the western half of the State, which is served by the Missoula office. The eastern half contains the State's largest city, Billings, with a city population of 109,577 (2019). Vital Statistics does not yet have population and death statistics for 2020.


MANNER OF DEATH:

Manner is used to distinguish whether a death is considered natural or unnatural. If deemed unnatural, the death is typically categorized as either accident, suicide, homicide, or in the absence of a clear result, undetermined.

ANCESTRY:

Based upon Montana's Census and Economic Information Center, the following ancestry groups comprise Montana's population in 2019: Caucasian 87.4%, Native American 7.3%, Hispanic 3.2%, Asian/Pacific Islander 1.1%, and Black/African American 1%.

Although comprising 12.6% of the population, Non-Caucasian citizens accounted for 37% of homicides, 16% of autopsied suicides, 20% of autopsied accidents, and 18% of autopsied overdoses in 2020. The homicide rate for Native Americans in 2020 **doubled** from prior year and accounted for 31% of the homicides. In addition, and significantly, for deaths of children and youth under 20 years, Non-Caucasians represented 33% of the total cases.

DEATHS ATTRIBUTABLE TO ALCOHOL OR DRUG INTOXICATION:

Medical Examiners performed 747 autopsies in death investigation cases. The toxicology section would have performed testing on most those cases. It was determined that 167 of those cases had toxicology results of significance. Below is a breakdown of the identified substances and corresponding drug results. The data below does not include deaths where the coroner did not have an autopsy performed.


SUICIDES AND HOMICIDES ATTRIBUTABLE TO FIREARMS:

2020 TURN-AROUND TIMES:

Turn-Around Time represents the number of days between the postmortem examination and the completion of the autopsy report. 69% of our reports in 2020 were completed within 90 days. MTMEO had a vacant medical examiner position for much of 2020, which resulted in longer turn-around times in our Billings location. Our goal is to complete 90% of our cases in 90 days.


FIVE YEAR TRENDS (2016-2020)
