### Biology

Please only use Bluestar if potential blood staining is NOT visible. If an item is sprayed with Bluestar, it is imperative that you circle the area(s) that fluoresce. Otherwise we will have no way to know where to swab.

Amy Howls and Emily Tuck have completed the interpretation portion of their training! They are continuing with the labwork segment of their DNA analyst training and we hope to have them fully online this fall.

#### Evidence

Please make sure you remove and keep the agency's copy of the sex kit forms before submitting kits.

Please double check that seals are intact, initialed, and dated before submission. As kit seals break easily during transit, evidence tape seals can be reinforced with clear tape.

### **Latent Prints**

If submitting an item to be analyzed by Chemistry and Latent Prints, please separate the suspected substance from the packaging prior to submitting it to the laboratory. We will return items without analyzing them until the suspected substance has been removed.

If you have a case going to trial, please let the laboratory know as soon as possible so that any opened requests can be worked prior to the trial.

#### Toxicology

The Breath Alcohol section will be providing training at MLEA and in Boulder. They are also planning an internal study regarding the effects of permanent retainers on breath testing.

We are welcoming two staff members: Delaney Peterson and Ollie Robson.
Delaney has started her training program, and Ollie will hopefully be joining us in the next few months to start training. We are happy to have them on board!

### Chemistry

All glass items, whether broken prior to submission or not, need to be submitted in a box.

We have had three confirmed cases of carfentanil in the last six months, all blue M30 tablets or blue tablet pieces.


