Based on our records, you may currently be, or may have previously been, employed by or engaged with Emcare, Inc., Sheridan Healthcorp, Inc., or one of their affiliates (“EmCare”) or American Medical Response, Inc. (“AMR”). EmCare values and respects the privacy of your information, which is why we are writing to advise you of a recent incident that may have involved some of your personal information. Although we have no reason to believe that your personal information has been misused for the purpose of committing fraud or identity theft, we are writing to advise you about the steps that we have taken to address the incident and provide you with guidance on what you can do to protect yourself.

AMR is an ambulance service provider that was a sister company to EmCare from 1997 until it was divested in March 2018. After the divestiture, EmCare supported the email application and other shared applications, until they could be separated out and placed on different servers. AMR recently became aware that an unauthorized third party obtained access to certain AMR employees’ email accounts. Upon learning of the incident, AMR promptly launched an internal investigation. In addition, AMR retained a leading forensic security firm to assist in its investigation. On June 15, 2019, AMR requested that EmCare notify any EmCare employee whose personal information was contained in an AMR employee’s e-mail account. This information included your name and Social Security number.
