Radiology Associates of Albuquerque, also known as RAA Imaging, and Advanced Imaging, LLC, also known as High Resolution, (together "RAA") are writing to make you aware of an incident that may affect your personal information. We want to provide you with information about the incident, our response, and steps you may take to help protect your personal information, should you feel it appropriate to do so. RAA is a radiological services provider. We have your information because you were a patient at a RAA facility.

**What Happened?** In August 2021, RAA learned that it experienced a cyber incident. We promptly took steps to secure our systems and commenced an investigation into the nature and scope of the incident. We have been working diligently to investigate this incident and confirm any information that may be affected. Through the investigation, we determined that certain documents stored within RAA's environment were copied from the system as part of the cyber incident between July 22, 2021, and August 3, 2021. The investigation further determined that certain email accounts were accessed without authorization at varying times between December 22, 2020, and July 15, 2021. Based on the investigation, RAA conducted a detailed review of data involved to determine the type of information present and to whom it related. This process to review the data and determine whose information may be affected has been ongoing and was recently completed in June 2022. RAA is now working to provide notice to those individuals whose information was potentially affected. You are receiving this notice because we determined that your information may be affected.

**What Information Was Involved?** The personal information potentially affected varies by individual. It may include: name; contact information; demographic information; medical information, such as treatment or diagnosis information, including information regarding mental or physical condition; medical record number; patient number; health insurance information, including billing/claim information, health insurance number, plan, group, and/or policy number, and/or Medicaid/Medicare identification; biometric data; date of birth; electronic signature; email/username and password/pin; marriage certificate; mother's maiden name; vehicle information (VIN, license plate number); financial account and/or credit/debit card information; driver's license or state/federal identification number; and/or Social Security number. *It is important to note that the information varies by individual and not all of these data types were potentially affected for each person.*

**What We Are Doing.** The confidentiality, privacy, and security of information within our care are among RAA's highest priorities. Upon learning of the event, we promptly took steps to secure our systems and investigate the full scope of the incident. While our response to the event is ongoing, we have taken additional steps to further enhance the security of our systems. In an abundance of caution, we are also notifying potentially affected individuals, including you, and providing information on steps you may take to help protect your information, should you feel it is appropriate to do so. We are also offering you access to Identity Monitoring at no cost to you for two years as an added precaution. Information on how to activate these services may be found in the attached "*Steps You Can Take to Help Protect Personal Information.*"

**What You Can Do.** We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and explanation of benefit forms and monitoring your free credit reports for suspicious activity and to detect errors. We also encourage you to review the information contained in the attached "*Steps You Can Take to Help Protect Personal Information*" and to activate the Identity Monitoring services we are making available to you.

### Activate Identity Monitoring

We have secured the services of Kroll to provide identity monitoring at no cost to you for two years. Kroll is a global leader in risk mitigation and response, and their team has extensive experience helping people who have sustained an unintentional exposure of confidential data. Your identity monitoring services include Credit Monitoring, Fraud Consultation, and Identity Theft Restoration.

### Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.

*For New Mexico residents*, you have rights pursuant to the Fair Credit Reporting Act, such as the right to be told if information in your credit file has been used against you, the right to know what is in your credit file, the right to ask for your credit score, and the right to dispute incomplete or inaccurate information. Further, pursuant to the Fair Credit Reporting Act, the consumer reporting bureaus must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to your file is limited; you must give your consent for credit reports to be provided to employers; you may limit “prescreened” offers of credit and insurance you get based on information in your credit report; and you may seek damages from violator. You may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active-duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act. You have been provided with access to the following services from Kroll:

### **Single Bureau Credit Monitoring**

You will receive alerts when there are changes to your credit data—for instance, when a new line of credit is applied for in your name. If you do not recognize the activity, you’ll have the option to call a Kroll fraud specialist, who will be able to help you determine if it is an indicator of identity theft.

### **Fraud Consultation**

To receive credit services, you must be over the age of 18 and have established credit in the U.S., have a Social Security number in your name, and have a U.S. residential address associated with your credit file.
