Notice of Data Security Incident

Dear [REDACTED],

We are writing to inform you of a recent data security incident that may have resulted in unauthorized access to your personal information. We take the privacy of your personal information seriously and want to provide you with information and resources you can use to protect your identity. This letter contains information about the incident and information about how to protect your personal information going forward.

What Happened and What Information was Involved:

Recently, Messerli & Kramer P.A. ("Messerli & Kramer") detected a network security incident. An unauthorized third-party infiltrated our network environment. We immediately engaged specialized third-party forensic and technical resources to respond to the incident. We have secured the network and the data that we maintain.

Upon discovery, we initiated a comprehensive investigation into the cause and extent of the unauthorized activity. An investigation revealed that the following categories of your information may have been exposed during the compromise: name, Social Security Number, driver's license/ID number, passport number, and medical information. Notably, the types of information affected varied by individual, and not every individual had every element exposed.

As of this writing, Messerli & Kramer has not received any reports of related identity theft since the date of the incident. Based on Messerli & Kramer's investigation and consultation with industry experts, Messerli & Kramer does not believe that the above referenced information has been made publicly available or distributed by an unauthorized party.

What We Are Doing:

Messerli & Kramer is committed to doing everything we can to protect the privacy and security of the personal information in our care. Upon detecting this incident, we moved quickly to initiate our incident response plan, which included fully securing our network and the data that we maintain. We conducted an investigation with the assistance of third-party forensic specialists and have reported this matter to law enforcement. We are reviewing our tools, policies, and procedures relating to the security of our systems and servers.

In response to the incident, we are providing you with access to **Single Bureau Credit Monitoring/Single Bureau Credit Report/Single Bureau Credit Score** services at no charge. These services provide you with alerts for twelve (12) months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in event that you become a victim of fraud. These services will be provided by Cyberscout through Identity Force, a TransUnion company specializing in fraud assistance and remediation services.

What You Can Do:

To enroll in Credit Monitoring services at no charge, please log on to <https://secure.identityforce.com/benefit/messerlikramer> and follow the instructions provided. When prompted please provide the following unique code to receive services: [REDACTED]

In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

At this time, there is no evidence that your information has been misused. However, we encourage you to take full advantage of this service offering. Call center representatives can answer questions or concerns you may have regarding protection of your personal information.

Enclosed you will find additional information regarding the resources available to you, and the steps that you can take to further protect your personal information.

Security Freeze: You also have the right to place a security freeze on your credit report. You may make that request by certified mail, overnight mail, regular stamped mail, or by following the instructions found at the websites listed below. The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse or a minor under the age of 16, this information must be provided for him/her as well):

- (1) full name, with middle initial and any suffixes;
- (2) Social Security number;
- (3) date of birth;
- (4) current address and any previous addresses for the past five years; and
- (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles.

The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue. As of September 21, 2018, it is free to place, lift, or remove a security freeze. You may also place a security freeze for children under the age of 16. You may obtain a free security freeze by contacting any one or more of the following national consumer reporting agencies:
