NOTICE OF [Extra1]

Dear Sample A. Sample,

The Hartwell Corporation (“Hartwell”) is writing to notify you of a recent data security incident that may have impacted your personal information. We want to provide you with information about the incident, our response, and steps you may take to better protect against possible misuse of your personal information.

What Happened? On April 20, 2023, we became aware of suspicious activity relating to a Hartwell email account. In response, we engaged third party forensic specialists to investigate the nature and scope of the activity. We determined that an unauthorized third party gained access to one email account between March 20, 2023 and April 19, 2023. We then undertook a comprehensive review of the contents of the affected email account out of an abundance of caution. On September 12, 2023, we confirmed that certain information relating to you was included in the affected account. At this time, we are unaware of any actual or attempted misuse of this information as a result of this incident.

What Information Was Involved? The investigation determined that your name and [Extra2], was included in the impacted dataset.

What We Are Doing. The confidentiality, privacy, and security of personal information within our care is important to us. Upon learning of the event, we investigated to determine the nature and scope of the incident. We also notified law enforcement. We are reviewing our existing policies and procedures to improve security and better protect against similar incidents in the future. As an added precaution, Hartwell is offering you access to twelve (12) months of complimentary credit monitoring and identity protection services through Experian. Details of this offer and instructions on how to enroll in the services may be found in the attached *Steps You Can Take to Protect Personal Information*.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements. Additional information may be found in the attached *Steps You Can Take to Protect Personal Information*.

Enroll in Credit Monitoring

To help protect your identity, we are offering complimentary access to Experian IdentityWorksSM for twelve (12) months.

If you believe there was fraudulent use of your information as a result of this incident and would like to discuss how you may be able to resolve those issues, please reach out to an Experian agent. Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
