Notice of Data Security Incident

Dear [REDACTED],

CellNetix Pathology and Laboratories (“CellNetix”) is writing to inform you of an incident that may have exposed your personal information. You are receiving this letter because you are a current employee of CellNetix. We take the security of personal information seriously. As such, this letter contains details about the incident and resources to help protect your personal information going forward.

What Happened:

On December 10, 2023, CellNetix experienced a network security incident that involved an unauthorized party gaining access to our network environment. Upon detecting the incident, we immediately shut off all access to the network and engaged a specialized third-party forensic incident response firm to assist with securing the network environment and investigating the extent of unauthorized activity.

What Information Was Involved:

CellNetix has found no evidence that your information has been misused. However, on December 19, 2023, we completed a comprehensive review of the data potentially impacted in this incident and determined that the following information may have been impacted: first and last name; Social Security number; driver’s license number or state identification card number; date of birth; military or passport identification number; and health insurance policy number or health insurance identification number.

**Please note that your banking information, credit card information, and/or financial information were not involved in this incident.**

What We Are Doing:

Data security is among CellNetix’s highest priorities. We have made immediate enhancements to our systems and security. We have also engaged appropriate experts to assist us in conducting a full review of our security practices and systems to ensure that enhanced security protocols are in place going forward.

We previously sent you instructions on how to utilize and enroll in Norton LifeLock, an employee benefit CellNetix provides free to all employees. We encourage you to sign up for this service if you have not already done so.

Additionally, in response to the incident, we are providing you with access to Single Bureau Credit Monitoring/Single Bureau Credit Report/Single Bureau Credit Score services at no charge. These services provide you with alerts for 12 months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in event that you become a victim of fraud. These services will be provided by Cyberscout through Identity Force, a TransUnion company specializing in fraud assistance and remediation services.

#### What You Can Do:

To enroll in Credit Monitoring services at no charge, please log on to <https://secure.identityforce.com/benefit/cellnetixpathandlab> and follow the instructions provided. When prompted please provide the following unique code to receive services: [REDACTED] In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information pertaining to your dependent for your dependent's protection to confirm your dependent's identity.

**Please keep this letter as you will need to reference the enrollment code above when calling or enrolling your dependent online.**

- (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles.

The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue. As of September 21, 2018, it is free to place, lift, or remove a security freeze.
