**Re: Notice of Data Security Incident**

Dear [REDACTED],

Rocky Mountain University of Health Professions “RMU” is writing to inform you of a recent data security incident that may have resulted in unauthorized access to your sensitive personal information. Currently, we are unaware of any fraudulent misuse of your personal information, but we are providing you with details of the incident, steps we are taking in response, and resources available to help you protect against the potential misuse of your information.

**What Happened?**

On April 28, 2023, RMU detected a website configuration error. Upon discovery of this incident, RMU immediately fixed the configuration issue and promptly engaged a specialized third-party cybersecurity firm to assist with securing the environment, as well as to conduct a comprehensive forensic investigation to determine the nature and scope of the incident.

Based on these findings, RMU, with the help of a specialized cybersecurity firm, performed data mining on the affected systems/accounts to identify the specific individuals and the types of information that may have been compromised. Data mining was completed on November 1, 2023.

On December 29, 2023, RMU finalized the list of individuals to notify.

**What Information Was Involved?**

Although RMU has no evidence that any sensitive information has been misused by third parties as a result of this incident, we are notifying you out of caution and for purposes of full transparency. Based on the investigation, the following information related to you may have been subject to unauthorized access: name, telephone, address, driver’s license, passport, social security number, date of birth, and, for some, medical information.

**What We Are Doing**

Data privacy and security is among RMU’s highest priorities, and we are committed to doing everything we can to protect the privacy and security of the personal information in our care. Since the discovery of the incident RMU resolved the website configuration error and took steps, and will continue to take steps, to mitigate the risk of future harm.

In light of the incident, we are providing you with access to Single Bureau Credit Monitoring/Single Bureau Credit Report/Single Bureau Credit Score services at no charge. These services provide you with alerts for twelve months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you

with proactive fraud assistance to help with any questions that you might have or in event that you become a victim of fraud. These services will be provided by Cyberscout through Identity Force, a TransUnion company specializing in fraud assistance and remediation services.

### **What You Can Do**

We encourage you to remain vigilant against incidents of identity theft and fraud, to review your account statements, and to monitor your credit reports for suspicious or unauthorized activity. Additionally, security experts suggest that you contact your financial institution and all major credit bureaus to inform them of such a breach and take whatever steps are recommended to protect your interests, including the possible placement of a fraud alert on your credit file. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

We would like to reiterate that, at this time, there is no evidence that your information was misused. However, we encourage you to take full advantage of the services offered.

**Monitoring:** You should always remain vigilant for incidents of fraud and identity theft by reviewing credit card account statements and by monitoring your credit report for suspicious or unusual activity.

**Security Freeze:** You have the right to place a security freeze on your credit report. A security freeze is intended to prevent credit, loans, and services from being approved in your name without your consent. To place a security freeze on your credit report, you need to make a request to each consumer reporting agency. You may make that request by certified mail, overnight mail, regular stamped mail, or by following the instructions found at the websites listed below. The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse or a minor under the age of 16, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue. As of September 21, 2018, it is free to place, lift, or remove a security freeze.
