#### Dear << Name1>>:

Rosen's Inc. and Rosen's Diversified, Inc. ("Rosen's") understand the importance of protecting information. We are writing to inform you of an incident that involved some of your information. This notice explains what happened, what we have done in response, and what you can do.

## What Happened?

We recently completed an investigation into an incident involving unauthorized activity in Rosen's, Inc.'s network that we identified on November 29, 2023. After learning of the incident, we immediately took measures to contain the activity and launched an investigation, and a cybersecurity firm was engaged. We also notified law enforcement and are supporting their investigation.

The evidence showed unauthorized activity in the Rosen's, Inc. network between November 21, 2023 and November 29, 2023. During that time, unauthorized actors viewed and obtained some of the files in the network. We conducted a careful review of the contents of these files and, on December 28, 2023, determined that one or more of the files contained your information.

#### What Information Was Involved?

The information consisted of your name, Social Security number, and for some individuals, your health insurance identification number and/or date of birth.

## What We Are Doing.

We wanted to notify you of this incident and to assure you that we take it seriously. As noted above, upon learning of this event, we immediately launched an investigation and took steps to mitigate the event. In addition, to help prevent something like this from happening again, we have taken and will continue to take steps to enhance our existing security measures.

#### What You Can Do.

We are paying for you to receive one year of access to Equifax Complete<sup>TM</sup> Premier credit monitoring. This product helps detect possible misuse of your information and provides you with identity protection solutions focused on immediate identification and resolution of identity theft. Activating this product will not hurt your credit score. For more information on identity theft prevention and Equifax Complete<sup>TM</sup> Premier, including instructions on how to activate your one year of access, as well as some additional steps you can take in response, please review the pages that follow this letter. Please note that you must complete the enrollment process yourself, as we are not permitted to enroll you in this product on your behalf.

If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also consider contacting your local law enforcement authorities and filing a police report. If you contact the police, you should obtain a copy of the police report in case you are asked to provide copies to creditors to correct your records. ### Fraud Alerts and Credit or Security Freezes:

Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft and have appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

How do I place a fraud alert on my credit reports? To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

Credit or Security Freezes: You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That is because most creditors need to see your credit report before they approve a new account. If they cannot see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. You will need to supply your name, address, date of birth, Social Security number and other personal information.

After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.
