

Notice of Data Security Incident



You are receiving this letter because you are a current or former patient of Community Memorial Healthcare (hereinafter "CMH"), a hospital located in Marysville, Kansas. We are writing in order to inform you of an incident that may have exposed your personal information. We take the security of your personal information seriously and want to provide you with information and resources you can use to protect your information.

What Happened and What Information was Involved:

On October 18, 2023, we detected and stopped a network security incident, in which an unauthorized third party accessed and disabled some of our systems. We immediately engaged third-party forensic specialists to assist us with securing the network environment and investigating the extent of any unauthorized activity. Our investigation, which concluded December 29, 2023, determined an unauthorized third party may have accessed certain individual personal information during this incident.

Our electronic medical record ("EMR") solution, where the vast majority of patient information is securely maintained, was not impacted by the incident. However, some billing records stored outside this system were potentially impacted. We found no evidence that your information has been specifically misused; however, it is possible that the following personal information could have been accessed by an unauthorized third party: first and last name, address, Social Security number, clinical information.

What We Are Doing:

Data security is one of our highest priorities. Upon detecting this incident we moved quickly to initiate a response, which included conducting an investigation with the assistance of IT specialists and confirming the security of our network environment. We notified law enforcement. We also wiped and rebuilt affected systems and have taken steps to bolster our network security. We also reviewed and altered our policies, procedures, and network security software relating to the security of our systems and servers, as well as how we store and manage data.

We are providing you with access to Single Bureau Credit Monitoring/Single Bureau Credit Report/Single Bureau Credit Score services at no charge. These services provide you with alerts for 12 months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. You are receiving this letter because you are a current or former employee and patient of Community Memorial Healthcare (hereinafter "CMH"), a hospital located in Marysville, Kansas. We are writing in order to inform you of an incident that may have exposed your personal information. We take the security of your personal information seriously, and want to provide you with information and resources you can use to protect your information.

What Happened and What Information was Involved:

On October 18, 2023, we detected and stopped a network security incident, in which an unauthorized third party accessed and disabled some of our systems. We immediately engaged third-party forensic specialists to assist us with securing the network environment and investigating the extent of any unauthorized activity. Our investigation, which concluded December 29, 2023, determined an unauthorized third party may have accessed certain individual personal information during this incident.

Our electronic medical record ("EMR") solution, where the vast majority of patient information is securely maintained, was <u>not</u> impacted by the incident. However, some patient billing records stored outside this system, as well as some employee records, were potentially impacted. We found no evidence that your information has been specifically misused; however, it is possible that the following personal information could have been accessed by an unauthorized third party: first and last name, address, Social Security number, clinical information.

What We Are Doing:

Data security is one of our highest priorities. Upon detecting this incident we moved quickly to initiate a response, which included conducting an investigation with the assistance of IT specialists and confirming the security of our network environment. We notified law enforcement. We also wiped and rebuilt affected systems and have taken steps to bolster our network security. We also reviewed and altered our policies, procedures, and network security software relating to the security of our systems and servers, as well as how we store and manage data.

We are providing you with access to Single Bureau Credit Monitoring/Single Bureau Credit Report/Single Bureau Credit Score services at no charge. These services provide you with alerts for 12 months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in event that you become a victim of fraud.
