**NOTICE OF [Extra1]**

Dear Sample A. Sample:

Top Gun Technology (“Top Gun”) writes to inform you of a recent event which may impact the privacy of some of your information. We are unaware of any actual or attempted misuse of your information at this time, but we are providing you with this letter as a precaution, to inform you of the event, our response, and steps you may take to protect your information, should you feel it is necessary to do so.

**What Happened?**

On October 29, 2023, Top Gun discovered evidence of unauthorized access into an employee’s email account. Upon discovery, Top Gun promptly took steps to secure the network, and launched an investigation with the assistance of third-party forensic specialists to determine the nature and scope of the activity. Through this investigation, Top Gun determined that an unknown actor accessed the email account between early and late October, 2023. As a result, Top Gun began a diligent and comprehensive review to identify sensitive information which may have been accessed and to identify the individuals whose information may have been present in the impacted email account. We are notifying you now because the investigation recently determined certain information related to you was stored within the accessed email.

**What Information Was Involved?**

The information involved includes your name and [Extra2]. While we have no indication that your information was subject to actual or attempted misuse as a result of this incident, we are notifying you out of an abundance of caution.

**What We Are Doing.**

Top Gun takes this incident and the security of your information seriously. Upon discovery, Top Gun promptly took steps to confirm the security of our systems and commenced an investigation with the assistance of third-party forensic computer specialists. Additionally, Top Gun secured our email tenant, implemented additional email security measures, issues a company-wide password reset, and increased the strength of our multi-factor authentication policies. Endpoint protection software was also implemented throughout Top Gun systems. We are notifying applicable regulatory authorities and consumer reporting agencies, as required by law.

As an added precaution, we are also offering twenty-four (24) months of complimentary access to credit monitoring and identity restoration services through Experian. Individuals who wish to receive these services must enroll by following the attached enrollment instructions.



**What You Can Do.**

We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors over the next 12 to 24 months. You can review the enclosed *Steps You Can Take to Help Protect Your Information* to learn helpful tips on steps you can take to protect against possible information misuse, should you feel it appropriate to do so.

### Enroll in Monitoring Services

To help protect your identity, we are offering complimentary access to Experian IdentityWorks<sup>SM</sup> for 24 months.

If you believe there was fraudulent use of your information as a result of this incident and would like to discuss how you may be able to resolve those issues, please reach out to an Experian agent. If, after discussing your situation with an agent, it is determined that identity restoration support is needed then an Experian Identity Restoration agent is available to work with you to investigate and resolve each incident of fraud that occurred from the date of the incident (including, as appropriate, helping you with contacting credit grantors to dispute charges and close accounts; assisting you in placing a freeze on your credit file with the three major credit bureaus; and assisting you with contacting government agencies to help restore your identity to its proper condition).

## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
