Mueller Water Products, Inc. (“Mueller”) is contacting you with an update on the October network incident. Our investigation has determined that this incident involves some of your personal information. This letter provides you with more information about the incident, our response, and additional resources to help protect your information, should you feel it is appropriate to do so.

**What Happened?** In late October 2023, Mueller became aware of unusual activity on our IT network. We promptly took steps to secure our systems and launched a comprehensive investigation. The investigation determined that certain files stored within Mueller’s environment were copied from the system by an unauthorized person(s) between October 25 and 26, 2023. We then undertook a comprehensive review of the relevant files to determine what information was present, to whom the information relates, and appropriate contact information for those individuals. Based on these efforts, on or around July 16, 2024, we confirmed that your information was present in the relevant files.

**What Information Was Involved?** We have determined that the information present in the relevant files includes your <<Data Elements>> and name. <<Var data 2/Medical Language>><<Var data 3/Medical Language>>

**What We Are Doing** We take this event and the security of information within our systems very seriously. We worked diligently to investigate and respond to this event, assessed the security of our environment, and determined what information was potentially impacted. We have also taken steps to review our existing policies and procedures and enhanced the security of our systems. As an added precaution, we are offering complimentary credit monitoring and identity theft protection services for <<12/24>> months through Equifax. **What You Can Do.** We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for unusual activity and to detect errors. Any suspicious activity should be promptly reported to the relevant financial institution. We also encourage you to review the information outlined in the attached *Steps You Can Take to Protect Personal Information* and to enroll in the complimentary credit monitoring and identify theft protection services we are offering. Please note, we are not permitted to enroll you in these services, so you will need to follow the instructions below to do so.

<sup>1</sup>WebScan searches for your Social Security Number, up to 5 passport numbers, up to 6 bank account numbers, up to 6 credit/debit card numbers, up to 6 email addresses, and up to 10 medical ID numbers. WebScan searches thousands of Internet sites where consumers’ personal information is suspected of being bought and sold, and regularly adds new sites to the list of those it searches. However, the Internet addresses of these suspected Internet trading sites are not published and frequently change, so there is no guarantee that we are able to locate and search every possible Internet site where consumers’ personal information is at risk of being traded. <sup>2</sup>The Automatic Fraud Alert feature is made available to consumers by Equifax Information Services

## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

## **Additional Information**

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General.
