Dear Sample A. Sample:

Tidal Basin Holdco, LLC (“Tidal Basin”) is writing to notify you of an event that may affect the privacy of some of your information. This notice provides information about this matter, our response, and resources available that we are offering at no cost to you to help protect your information, should you feel it is appropriate to do so.

**What Happened?** On or about August 10, 2024, Tidal Basin identified suspicious activity on its computer network. Tidal Basin quickly began an investigation to determine the full nature and scope of the activity. Through the investigation, we determined that on August 10, 2024, an unauthorized actor copied certain files and folders from Tidal Basin’s network. We promptly began a review of the relevant files and folders to determine what information was present and to whom it related. We recently completed this review, and worked thereafter to provide notice to potentially impacted individuals as quickly as possible.

**What Information Was Involved?** Our investigation determined that the following information related to you was present within the reviewed files and folders: name, [Extra2].

**What We Are Doing.** We take the confidentiality, privacy, and security of information in our care seriously. In response to this event, we promptly took steps to secure our systems and began a detailed investigation to determine the full nature and scope of the event. As part of our ongoing commitment to the privacy of information in our care, we are reviewing our policies, procedures, and processes related to the storage of and access to personal information.

Although we do not have any evidence of fraud or attempted identity theft related to this event, as an added precaution, we are offering you access to 24 months of complimentary credit monitoring and identity theft protection services through Experian. If you wish to activate these services, you may follow the instructions on the next page of this letter.

**What You Can Do.** We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. You can also enroll in the complimentary monitoring services that we are offering to you. Please also review the *Steps You Can Take to Help Protect Personal Information* section of this letter for additional information and resources available to you.

### Enroll in Monitoring Services

To help protect your identity, we are offering complimentary access to Experian IdentityWorks<sup>SM</sup> for 24 months.

## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
