Orthopaedic Associates of Allentown dba OAA Orthopaedic Specialists (“OAA”) is writing to inform you of a recent incident that may affect the security of some of your information. While we are not aware of any actual or attempted misuse of your information, we are providing you with an overview of the incident, our response, and steps you may take to better protect against the possibility of identity theft and fraud, should you feel it necessary to do so.

**What Happened?** On September 24, 2021, OAA became aware of suspicious activity related to certain internal computer systems and servers. We immediately took steps to secure our network, minimize any disruption to operations, and launched an investigation with the assistance of third-party forensic and cybersecurity specialists in the nature and scope of the event. Through this investigation, we determined that an unauthorized actor placed malware within the OAA environment that disrupted operations of certain OAA systems. The investigation further determined that the unauthorized actor may have accessed or acquired certain information contained in impacted OAA systems between September 17, 2021 and September 24, 2021. On or about October 25, 2021, the investigation determined that certain OAA patient information may be impacted as a result of this event.

**What Information Was Involved?** Upon learning this information, we began an in-depth manual review of the impacted files in order to confirm the presence of patient information. While this review is ongoing, OAA is notifying you out of an abundance of caution because the investigation determined that your <<Variable Text 1>> was present in the impacted files at the time of the incident. To date, OAA has not received any reports of actual or attempted misuse of your information.

**What We Are Doing.** We take this incident and the security of patient information within our care very seriously. In addition to the steps described above, as part of our ongoing commitment to the privacy of information in our care, we are working to review our existing policies and procedures, to provide additional training programs to employees, and are implementing additional safeguards to further secure the information in our systems.

**What You Can Do.** We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements, monitoring your free credit reports and Explanation of Benefits for suspicious activity, and to detect errors over the next 12 to 24 months. ## STEPS YOU CAN TAKE TO HELP PROTECT YOUR INFORMATION

### **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.

You may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active-duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
