Dear Sample A. Sample:

DCI Engineers (“DCI”) writes to inform you of a recent event that may impact the security of certain information related to you. This letter provides information about the event, our response, and the resources available to assist in safeguarding your information, should you feel it is appropriate to do so.

**What Happened?** On February 20, 2023, we became aware of suspicious activity on our computer network. We immediately launched an investigation to determine the nature and scope of the activity with assistance from outside specialists. We also promptly reported the event to federal law enforcement. Through our investigation, we learned that an unauthorized actor accessed our network between February 18, 2023 and February 21, 2023, and potentially viewed or copied certain files stored on our network.

In an abundance of caution, we undertook a thorough review of the information that could have been impacted during the event to determine whether sensitive information was present. We then worked diligently to identify address information for potentially affected individuals and recently completed that review.

**What Information Was Involved?** The types of your information that may have been impacted by this event are your name, [insert data elements].

**What We Are Doing.** The security of information in our care is a top priority for DCI. We quickly responded to this event by securing our network and determining what sensitive information may have been impacted. As an added precaution, we are providing you 24 months of complimentary access to credit monitoring and identity restoration services through Experian.

**What You Can Do.** We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and credit reports for suspicious activity and to detect errors. There, you will also find additional details about the credit monitoring services we are offering and how to enroll.

### Enroll in Credit Monitoring

To help protect your identity, we are offering complimentary access to Experian IdentityWorks<sup>SM</sup> for 24 months.

## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. You should be aware, however, that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
