## NOTICE OF [Extra2]

GeoSouthern Energy Corporation and GEP Haynesville II, LLC (collectively “GeoSouthern”), a petroleum and natural gas exploration and production company headquartered at 1425 Lakefront Circle, The Woodlands, Texas 77381, is writing to make you aware of a recent event involving certain information related to you. This letter contains information about what happened, our response, and the resources available to you to safeguard your information, should you feel it appropriate to do so. GeoSouthern values and respects the privacy of your information and prioritizes its confidentiality and security.

**What Happened?** On December 21, 2022, we became aware of suspicious activity on our network environment and promptly began a forensic investigation into the scope and nature of this activity. The investigation determined that there was unauthorized access to certain systems between December 15, 2022 and December 21, 2022. Our comprehensive forensic investigation ascertained sufficient information regarding the information at risk and the residency of potentially affected individuals on May 25, 2023. The information at risk relates to individuals who either were or are employees of GeoSouthern, their dependents, and/or one its related entities, or gave information to GeoSouthern, and/or one of its related entities, regarding their ownership of real property and any payments related thereto.

**What Information Was Involved?** The information related to you that was in the relevant files includes your [Extra1], and name.

**What We Are Doing.** We take this incident seriously and have been working diligently to investigate and respond. We are reviewing and enhancing our security policies and procedures, and implementing additional safeguards. We have also reported this to federal law enforcement. As an added precaution, we are also offering you complimentary access to twenty-four (24) months of credit monitoring and identity theft restoration services, through Experian. You will need to enroll yourself in these services if you wish to do so, as we are not able to activate them on your behalf.
