We write to inform you about an event that affected our computer network, our response to this event, and steps you may take should you feel it is appropriate to do so.

**What Happened?** On December 22, 2022, we identified our computer network was damaged by an unauthorized party. In response, we began an investigation to determine what occurred. We learned on January 11 that certain information about our clients was accessed without authorization on or about December 21, 2022.

**What Information Was Involved?** We took steps to secure the data that was accessed and do not have any evidence to suggest your information was viewed or otherwise subject to misuse. However, we did identify client names, Social Security numbers, and financial account numbers among the accessed data. We stress that your assets are held by a third-party custodian (Charles Schwab, US Bank, etc.) and have not been impacted by this incident. We use third-party custodians as a critical “safety wall” to separate and protect client assets.

**What We Are Doing.** We take this event and the security of information in our care seriously. As part of our ongoing commitment to the privacy of information, we are evaluating additional technical security measures, and existing policies and procedures to mitigate reoccurrence of this type of event. Further, we are offering complimentary credit monitoring and identity protection services to you. Please see below for information about how to access the services.

**What You Can Do.** As always, we encourage all of our Ferguson Wellman, West Bearing and Octavia Group clients to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and free credit reports for suspicious activity and to detect errors. We also recommend you review the “Steps You Can Take To Protect Personal Information” section of this letter. Further, you may enroll in the offered complimentary credit monitoring and identity protection services. The enrollment instructions are in the next section of this letter. Please note, due to privacy restrictions, we are unable to automatically enroll you in the complimentary monitoring services.

**Other Information.** We discovered damage to the software used to generate our performance reports. We have a separate program in place to generate detailed and accurate performance reports. Our planned migration to

this new reporting system is occurring sooner than anticipated. We know that our reporting is extremely important to you, and we look forward to your feedback on these reports.

### Enroll in Monitoring Services

To help protect your identity, we are offering a complimentary 24-month membership of Experian's IdentityWorks<sup>SM</sup>. This product provides you with superior identity detection and resolution of identity theft. To activate your membership and start monitoring your personal information please follow the steps below:

## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
