Dear Sample A. Sample:

Haynes International, Inc. (“Haynes”) writes to inform you of a recent event that may affect some of your information. Haynes takes this event very seriously and the confidentiality, privacy, and security of information in our care is among our highest priorities. While there is no evidence of actual or attempted misuse of any information, we are providing you with an overview of the event, our response, and resources to help further protect your information, should you feel it necessary to do so.

### What Happened?

On June 10, 2023, Haynes discovered some suspicious activity on our systems and that certain systems were inaccessible as a result of a malware attack. Haynes immediately took all systems offline and took steps to ensure the security of the network. Haynes also launched an investigation into the nature and scope of the event. The investigation determined that between June 6, 2023, and June 10, 2023, an unauthorized actor gained access to certain Haynes systems and may have accessed or acquired information on these systems.

As part of the investigation into the nature and scope of the event, Haynes undertook a thorough and comprehensive review of the impacted data to determine whether it included any sensitive information and to whom the information relates. This review was completed on October 13, 2023 and Haynes is notifying you because the review determined that some of your information was within the impacted data.

### What Information Was Involved?

The information that relates to you includes your [Extra1] and name. To date, Haynes is not aware of any actual or attempted misuse of your information as a result of this event and is providing you this notice out of an abundance of caution.

### What We Are Doing.

Haynes takes this event and the security of information in our care very seriously. Upon learning of the event, we moved quickly to respond and investigate the event, assess the security of our network, and notify potentially impacted individuals. As part of Haynes’ ongoing commitment to information security, we are currently reviewing our policies and procedures, as well as assessing new cybersecurity tools, to reduce the risk of a similar event from occurring in the future. Haynes also notified law enforcement and will be notifying relevant regulators, as required.

Haynes is also offering you [Extra3] months of complimentary credit monitoring through Experian. You must enroll in these services as Haynes cannot do so on your behalf. Enrollment instructions can be found in the enclosed *Steps You Can Take to Help Protect Your Information* below.

**What You Can Do.**

We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. Please review the enclosed *Steps You Can Take to Help Protect Your Information*, which includes further information on what you can do to protect your information against misuse, should you feel it necessary to do so. Additionally, Haynes encourages you to enroll in the complimentary credit monitoring being offered.

## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
