Quick Cards:

On the two pages below, you will find an easily printable “Quick Card” for law enforcement. These Quick Cards are intended to be printed double-sided, laminated, and kept for easy reference in the field.

Topics in this Quick Card:

One side displays a list of standard required discovery items that should be included in most DUI cases. The reverse side displays a list of required discovery items, typically proof of certification or compliance with legal requirements, based upon the type of alcohol or drug testing that was conducted during the investigation.
