On or about March 18, 2018, we discovered that malware infected the servers that host our electronic medical records. We immediately began an investigation and engaged a national forensic firm. Our investigation determined that an unauthorized person accessed the servers on September 27, 2016. The information potentially accessed may include your name, address, date of birth, diagnosis, medications, clinical and treatment information contained in your medical record. Your social security number and financial information were not included with the information.

At this time, we have no reason to believe that your information has been misused in any way. However, as a precaution, we wanted to notify you and assure you that we take it seriously. We recommend that you review any billing statements or explanation of benefits statements that you receive. If you see services that you did not receive, please contact the provider or insurer immediately.

We sincerely regret any inconvenience or concern this incident may cause. To help prevent something like this from happening in the future, we have enhanced the complexity of our password requirements and the security of our system.
