- Copy of the applicant's Internal Revenue Service (IRS) determination letter showing their tax-exempt status per federal code 26 USC § 501(c)(3).
 - The date of this letter must be at least one year prior to the application date.
- Copy of signed charter or bylaws including board of directors.
- Proof that the organization is in good standing with the Montana Secretary of State.
- When a Parent Company exists:
 - Proof that the applicant is in good standing and has permission from their parent company.
- Proof that the organization's headquarters or base of operations is in Montana.
 - An item showing a Montana address associated with the business, - for example a lease agreement, utility bill, etc.
 - Proof the organization has an active telephone number - for example a copy of a telephone bill.
- Proof the organization banks with a Montana banking institute.
 - Bank routing and account information must be faxed to Attn: Specialty Plates at (406) 444-2086.
- W-9 form, which can be obtained at www.irs.gov

- Once license plate design is approved and released, donations will be received electronically using the information provided on the required Electronic Funds Transfer (EFT) form, available here: <https://dojmt.gov/wp-content/uploads/204-Electronic-Funds-Transfer-Sign-Up-2019.pdf>
- A check in the amount of \$4,120 **made payable to Montana Correctional Enterprises** (includes 3% administration fee per § 61-3-111, MCA).
 - The DOJ, in consultation with MCE, will approve or reject the initial plate design (proof) based on the specifications outlined. The DOJ will return rejected designs to the sponsor's liaison outlining the reasons for disapproval.
 - Once the initial or reworked plate design is approved by DOJ, MCE, and the Montana Highway Patrol; the sponsor must approve the design by signing the back of the proof.
 - Applications may take up to six weeks to process.

If this is a Name Change Request, you must include the following documents:

- New Application (MV115)
- Copy of the applicant's Internal Revenue Service (IRS) determination letter showing their tax-exempt status per federal code 26 USC § 501(c)(3).
 - The date of this letter must be at least one year prior to the application date.
- Proof that the organization is in good standing with the Montana Secretary of State.

If this is a Plate Design Revision Request, you must include:

- Appropriate application to sponsor a specialty plate.
 - MV115 for 501(c)(3) or MV116 for governmental body
- All supporting documentation listed on the application.
- An electronic copy (i.e., flash drive) of the plate design in a layered format (software must be Adobe Illustrator, Photoshop, or CorelDraw).
- A full color hard copy of the plate design.
- A check in the amount of \$4,120 **made payable to Montana Correctional Enterprises** (includes 3% administration fee per § 61-3-111, MCA).
 - The DOJ, in consultation with MCE, will approve or reject the initial plate design (proof) based on the specifications outlined. The DOJ will return rejected designs to the sponsor's liaison outlining the reasons for disapproval.
 - Once the initial or reworked plate design is approved by DOJ, MCE, and the Montana Highway Patrol; the sponsor must approve the design by signing the back of the proof.
 - Applications may take up to six weeks to process.
