Instructions for Montana residents that request to renew their standard driver license (Noncommercial) by mail.

In response to the COVID-19 pandemic, MVD has been authorized to modify the requirements for mail-in renewals. These changes are temporary. You are eligible even if your last renewal was online or by mail.

Expiration date:

- If you are a U.S. citizen or permanent resident, your license will expire a maximum of two years from your expiration date depending on your age (see chart below).
- If you are a foreign national who is temporarily authorized to be in the United States, your license will expire either two years from your expiration date or the date you are authorized to be in the United States.

Next renewal:

- Your next renewal must be completed in person at a driver license exam station within the state of Montana.

Requirements:

- A valid Montana driver license that will expire in the next 6 months or your license expired on or after March 16, 2019.
- License has not been suspended or revoked in any state.

To renew your standard driver license by mail, you must do the following:

Your application cannot be processed unless **ALL** instructions are followed completely.

- Complete, **sign**, and submit ALL pages of:
 - Mail-in Renewal (Standard Driver License) application
- Enclose:
 - If you are a foreign national, proof of Authorized Presence. Photocopy of:
 - Permanent Resident Card –I551
 - Documents showing temporary foreign national is authorized to be in the United States. For a complete list visit <https://dojmt.gov/driving/required-docs/>.
 - Photocopy of your Montana driver license or other acceptable proof of identity. For a complete list visit <https://dojmt.gov/driving/required-docs/>.

I understand that if I file a change of address with the U.S. Postal Service, I must complete, sign, and return a confirmation notice mailed to me by the county election office.

Voter Applicant Affirmation

I affirm under penalty of perjury that the information on this application is true, that I am a citizen of the United States, that I will be at least 18 years old on or before the next election that I will have been a resident of Montana for at least 30 days prior to the next election, and that I am not serving a felony conviction in a penal institution nor have been found to be of unsound mind by a court. I understand that if I have given false information on this application, I may be subject to a fine or imprisonment, or both, under federal and/or state law. By signing you authorize the Motor Vehicle Division to use your electronic signature for voter registration purposes.

The affirmation on this application for voter registration must be signed by the applicant. Failure to do so will prevent application from being processed.

Where you submit this form and your decision to not vote is confidential, and this information can only be used for voter registration purposes.
