



Montana REAL ID Checklist - Appointments are Required to Apply

Step 1

Name, Date of Birth & Authorized Presence

Provide ONE

- Certified US birth certificate
- Valid unexpired US Passport
- Certificate of Naturalization
- Certificate of Citizenship
- Consular report of birth abroad
- Permanent Resident Card, form I-551

***Don't have one of these documents?
Go to Step 1A**

Step 2

Social Security Number (Must have full SSN and name)

Provide ONE

- Social Security Card (not laminated)
- W-2 form
- SSA-1099 form
- Non-SSA-1099 form
- Pay stub



Step 3

Montana Residency

(All documents must have your name, current physical address, and be unexpired or dated within one year of expiration)

Provide TWO, may be same type

Step 1A *May not apply to all customers

Name & Date of Birth

Provide ONE

- Valid unexpired out-of-state REAL ID driver license or ID
- Form I-766 or Form I-688B unexpired employment authorization document
- Unexpired foreign passport with a valid unexpired US employment authorization document, accompanied by form I-94 or I-551 stamp

Authorized Presence

Provide TWO, may not be same type

- Valid unexpired out-of-state REAL ID driver license or ID
- Form I-766 or Form I-688B unexpired employment authorization document
- Documentation issued by a federal agency demonstrating authorized status
- Unexpired foreign passport with a valid unexpired US employment authorization document, accompanied by form I-94 or I-551 stamp

Step 4 *May not apply to all customers

Name Change Documents

(When your current legal name doesn't match the documents you submit, you must prove ALL legal name changes)

Provide ONE per name change

Important: MVD will accept foreign documents when translated.

All documents must be unaltered. Some must be certified by the issuing agency. MVD must verify some documents.

If you are unable to provide a document from Step 1 & 2, you may request an exception for MVD approval. You must complete a form (found online), have a good reason for the exception, and give additional or alternative documentation.
