Biology

We are changing our reporting procedure for the Y-screening process. You will now receive a Serology Report with the results of the screening, whether positive or negative.

Per our submission policy, we only accept touch-type items as a last resort in crimes against people, not in property crimes.

Chemistry

The legislature approved the addition of substituted fentanyl and benzodiazepine compounds into Schedule 1 effective Oct. 1st. This will reduce the frequency of the analogue law and allows us to schedule compounds based on structure.

We welcome questions and are happy to provide tours or training to law enforcement or county attorneys to explain processes or technology.

Evidence

E-EVIDENCE - I Please keep us updated with personnel changes, including new officers and when people leave.

E-EVIDENCE-I When submitting evidence, please use the officer's full first and last name, not just a badge number.

E-EVIDENCE - I Please read and follow the instructions inside tox kit boxes. This includes fully sealing the top of blood tubes.

Latent Prints

As a reminder, when submitting an item for both LP and Chemistry analysis, please separate the controlled substance from the packaging so that the items can go to their respective sections separately. Latents will not handle any item with a measurable amount of controlled substance inside the packaging and will send the item back to the agency for it to be removed. This includes any liquid in syringes.

Toxicology

The Toxicology section has validated a method for the detection of 128 different drugs at once. This test will be standard on DUI submissions that meet the requirements for drug testing, sex assault cases, and some postmortem cases.

Firearms

We are expecting delivery of our Virtual Comparison Microscope in June. It could be used for casework before the end of this summer, after passing validation.

As a reminder to our law enforcement partners, be vigilant in checking the function and safety features of your firearms. We recently had a rifle with a malfunctioning trigger that fired both when the trigger was pulled **and** released.

Miscellaneous

Remember that all kits (blood, tox, UA, & DNA) have expiration dates. Kits are expensive, so please don't let them expire in a drawer or patrol car or on a shelf!

When requesting autopsies, please include as much information as possible about the decedent and circumstances.
