RE: NOTICE OF DATA BREACH

The protection and privacy of your personal information is one of our highest priorities. Because of this, we are writing to make you aware of a recent data security incident that may have involved some of your information. **We have no reason to believe that anyone's information has been misused.** Nonetheless, we are writing to advise you about the incident and to provide you with guidance on what you can do to protect against fraud, should you feel it is appropriate to do so.

What Happened? We recently learned that an unknown, third party accessed an email account and may have acquired certain emails from one of our employees. Upon discovering the incident, we promptly began an internal investigation, confirmed pertinent passwords were updated and reviewed the contents of the emails involved to determine if they contained any personal information.

What Information Was Involved? On September 20, 2023, we determined that certain emails contained personal information. The type of information in the emails differs from individual-to-individual, but may have included your name, Social Security number, and for some individuals, a financial account number(s).

What We Are Doing. In addition to the actions described above, we are evaluating steps to reduce the risk of this type of incident occurring in the future, including enhancing our technical security measures. Although we are not aware of any instances of fraud or identity theft involving your information, we are also offering a complimentary one-year membership of **Equifax Credit Watch™ Gold**. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on immediate identification and resolution of identity theft. This service is completely free to you, and enrolling in this program will not hurt your credit score. **For more information on identity theft prevention, including instructions on how to activate your complimentary one-year membership, please see the additional information provided in this letter.**

What You Can Do. While we have no evidence that your information has been misused, we encourage you to take advantage of the complimentary credit monitoring included in this letter. You can also find more information on steps to protect yourself against possible identity theft or fraud in the enclosed *Additional Important Information* sheet.

Fraud Alerts: You may want to consider placing a fraud alert on your credit report. A fraud alert is free and will stay on your credit report for one (1) year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. To place a fraud alert on your credit report, contact any of the three national credit reporting agencies using the contact information listed above. Additional information is available at www.annualcreditreport.com.

Credit and Security Freezes: You may have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze can be placed without any charge and is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company. Since the instructions for how to establish a credit freeze differ from state to state, please contact the three major credit reporting companies as specified below to find out more information:
