Portland State University Foundation (“PSU Foundation”) is writing to inform you of a recent data security event that may involve some of your information. We take this event seriously and are providing you with information about the event and steps you may take to help protect your information, should you feel it is appropriate to do so.

What Happened? On July 1, 2020, PSU Foundation became aware of unusual activity within certain employees’ email accounts. In response, PSU Foundation launched an investigation to determine the nature and scope of the activity and found that a limited number of email accounts were logged into by an unauthorized actor between May 26, 2020 and July 1, 2020.

Because we were unable to determine whether email messages or file attachments were actually viewed by the unauthorized actor, we next commenced an extensive review of the impacted email accounts’ contents to determine what sensitive information may have been present in the impacted email accounts. Once we confirmed that the email accounts contained sensitive information for certain individuals, we next needed to conduct a review to confirm the best address at which to notify impacted individuals in writing.

What Information Was Involved? The information involved is your name, <<Breached Elements>>. To date, we are unaware of any actual or attempted misuse of this information as a result of this incident and are sending this notice out of an abundance of caution.

What We Are Doing in Response? In addition to launching an internal investigation into this incident, we are reviewing our existing policies and procedures and will implement additional safeguards, as needed. In an abundance of caution, we are notifying you, so that you may take further steps to best protect your personal information, should you feel it is appropriate to do so.

Although we are unaware of any actual or attempted misuse of your personal information as a result of this incident, we are offering you access to complimentary credit monitoring through TransUnion. In addition, we have provided notice to appropriate regulatory authorities.

What Can You Do? We encourage you to remain vigilant against incidents of identity theft and fraud, to review your account statements, and monitor your credit reports for suspicious activity. You may also review the information contained in the attached “Steps You Can Take to Help Protect Your Information.” There you will also find more information on the credit monitoring and identity protection services we are making available to you. While PSU Foundation will cover the cost of these services, you will need to complete the activation process.

Enroll in Credit Monitoring

Complimentary Two-Year myTrueIdentity 3B Credit Monitoring Service

As a safeguard, we have arranged for you to enroll, at no cost to you, in an online, three-bureau credit monitoring service (myTrueIdentity) for two years provided by TransUnion Interactive, a subsidiary of TransUnion®, one of the three nationwide credit reporting companies.

How to Enroll: You can sign up online or via U.S. mail delivery

- To enroll in this service, go to the *myTrueIdentity* website at **www.MyTrueIdentity.com** and, in the space referenced as “Enter Activation Code,” enter the 12-letter Activation Code **<<Insert Unique 12-letter Activation Code>>** and follow the three steps to receive your credit monitoring service online within minutes.
- If you do not have access to the Internet and wish to enroll in a similar offline, paper-based, three-bureau credit monitoring service, via U.S. mail delivery, please call the TransUnion Fraud Response Services toll-free hotline at **1-855-288-5422**. When prompted, enter the six-digit telephone passcode **<<Insert static 6-digit Telephone Pass Code>>** and follow the steps to enroll in the offline credit monitoring service, add an initial fraud alert to your credit file, or to speak to a TransUnion representative if you believe you may be a victim of identity theft.

You can sign up for the online or offline credit monitoring service anytime between now and **<<Enrollment Deadline>>**. Due to privacy laws, we cannot register you directly. Please note that credit monitoring services might not be available for individuals who do not have a credit file with TransUnion or an address in the United States (or its territories) and a valid Social Security number. Enrolling in this service will not affect your credit score.

ADDITIONAL DETAILS REGARDING YOUR 24-MONTH COMPLIMENTARY CREDIT MONITORING SERVICE:

- Once you are enrolled, you will be able to obtain two years of unlimited access to your TransUnion credit report and credit score.
