#### **Notice of Data Breach**

We are writing to tell you about a data security incident that may have exposed some of your personal information. We take the protection and proper use of your information very seriously. For this reason, we are contacting you directly to explain the circumstances of the incident.

# What happened?

Between February 2016 and December 2016, Aptos, the company that hosts our e-commerce website, experienced an unauthorized accessed by a third-party that affected approximately 40 of their business clients, including Pianoworks. Their system was accessed in a way that allowed the unauthorized third-party persistent access to customer purchase data both during that time period, as well as historical data that pre-dates the incident.

The incident was initially reported to the FBI Cyber Division and the U.S. Department of Justice. Law enforcement asked that Aptos defer notification of this to us until earlier this year. We are now notifying our customers as we have learned of the scope of this incident.

# What information was involved?

The unencrypted information involved may have included your name, address, phone number, email address. The encrypted information involved may have included your payment card information, including card type, payment card number, and expiration date.

# What we are doing.

In addition to cooperating with FBI Cyber Division and U.S. Department of Justice, Aptos has retained the services of Mandiant, a leading cybersecurity firm, to review the incident and strengthen the e-commerce platform. Several of their recommended security measures have already been initiated. As of this notification, we have no confirmation that any card data has been misused.

To help relieve concerns and restore confidence following this incident, we have secured the services of Kroll to provide identity monitoring at no cost to you for one year. Kroll is a global leader in risk mitigation and response, and their team has extensive experience helping people who have sustained an unintentional exposure of confidential data. Your identity monitoring services include Credit Monitoring, Web Watcher, Fraud Consultation, and Identity Theft Restoration.

**Fraud Alert.** You may place a fraud alert in your file by calling one of the three nationwide credit reporting agencies above. For that reason, placing a fraud alert can protect you, but also may delay you when you seek to obtain credit.

Security Freeze. You have the ability to place a security freeze on your credit report.

A security freeze is intended to prevent credit, loans and services from being approved in your name without your consent. To place a security freeze on your credit report, you may be able to use an online process, an automated telephone line, or a written request to any of the three credit reporting agencies listed above. The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue. The credit reporting agencies may charge a fee to place a freeze, temporarily lift it or permanently remove it. The fee is waived if you are a victim of identity theft and have submitted a valid investigative or law enforcement report or complaint relating to the identity theft incident to the credit reporting agencies. (You must review your state's requirement(s) and/or credit bureau requirement(s) for the specific document(s) to be submitted.)

For Massachusetts residents: The fee for each placement of a freeze, temporary lift of a freeze, or removal of a freeze is \$5.

**Federal Trade Commission and State Attorneys General Offices.** If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your home state. You may also contact these agencies for information on how to prevent or avoid identity theft.
