- The County Treasurer's Office will forward the Declaration to the Motor Vehicle Division. Once processed by the Motor Vehicle Division, the Declaration will be returned to you, at which time **you must resubmit it to the Clerk and Recorder's Office to complete the process.**
- In order for the manufactured home to be reversed as an improvement to real property, **a certified copy of this statement must be provided to the County Appraisal/Assessment Office.**
