We are writing to inform you of an incident which may have involved an unauthorized disclosure of your personal information.

### What Happened?

On April 18, 2018 a document with your personal information was sent to an unauthorized party.

### What Information Was Involved?

This incident may have resulted in a disclosure of the following information: Name, address, loan number, social security number, and interest earned.

#### What Are We Doing to Protect You?

First and foremost, we want to ensure the protection of your personal information. We have notified the appropriate state agency and have taken additional security steps to help prevent future incidents. We have also requested the recipient destroy the data that was received in error.

To help protect your identity, we are offering a **complimentary** credit monitoring service through Kroll Inc. If you wish to enroll in this service, simply contact us at the number above and request a Kroll Enrollment package. This package will have information regarding what is being offered, and how to enroll, if you do wish to enroll in this service. Although there will be no cost to you, the choice to enroll is entirely yours, and you must contact us to initiate the service.

In addition to enrolling in credit monitoring services through Kroll, there are additional steps you can take to protect yourself from fraudulent activity and identity theft:

- Obtain a free copy of your credit report maintained by each of the three credit reporting agencies by visiting <u>www.annualcreditreport.com</u> or by calling toll-free 877-322-8228.
  - Requests can be made in writing to: Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA 30348-5281
- Review your reports and bank statements carefully. If you find anything you do not understand or that is incorrect, contact the appropriate credit reporting agency.
- Remain vigilant for incidents of fraud and identity theft.
  - If you suspect fraudulent activity, contact your local law enforcement agency, the Attorney General of your state, and the Federal Trade Commission.
  - If you suspect that you may be the victim of identity theft, you can contact one or more of the national consumer reporting agencies for information on how to place a fraud alert or a security freeze on your credit report. Fees may be charged by the agency depending on the laws of your state.
