How long do these take for the division to process?

These can take a week or more for the division to process and complete applications with payment need to be submitted **at least 10 working days before the event.**

Can I apply on TAP and then mail payment?

Yes, you can submit the application on TAP and mail the payment. If you would like to pay via check, please find the corresponding form on our forms page for the activity you would like to apply for and mail the check and completed application in together. Non-login applications cannot be paid for on TAP until the Division reviews the application. Once this is complete it can be paid online.

What happens if my TAP payment doesn't go through?

If your permit request is processed automatically by TAP and then payment fails to process, you will be contacted by the division to provide alternative payment.


