FREQUENTLY ASKED QUESTIONS

What live gaming permits are available?

Live Keno/Bingo, Live Card Table(s), Small Stakes Tournament, and Large Stakes Tournaments can be added to an existing and active Gambling Operator Account (GOA).

Note: MCA 23-5-119 Appropriate Alcoholic Beverage License for Certain Gambling Activities governs which parts of Title 23, Chapter 5 licensees are allowed to offer. 23-5-119. Appropriate alcoholic beverage license for certain gambling activities, MCA (mt.gov)

How long do these take for the division to process?

Large Stakes Card Tournaments are the only option that need to be proceeded by division personnel. These are required to be submitted at least 5 business days before the event per ARM 23.16.1102.

Live Card Tables, Live Keno/Bingo, and Small Stakes Tournaments are processed automatically after payment is submitted on TAP and you should receive an updated VGM Permit same day.

Can I apply on TAP then mail payment?

Submitting the application on TAP requires payment in order to submit the application. If you would like to pay via check, please find the corresponding form on our forms page for the activity you would like to add and mail the check and completed application in together. What happens if my payment doesn't go through?

If your permit request is processed automatically by TAP and then payment fails to process, you will be contacted by the division to provide alternative payment.
