## Re: Notice of Data Breach

Thomas Cuisine is writing to notify you of a recent data security incident that may have impacted the security of some of your personal information. Although at this time there is no indication that your information has been misused in relation to this incident, we are providing you with information about the incident, our response to it, and information related to what you may do to help protect your personal information, should you feel it appropriate to do so.

**What Happened?** Earlier this year, Thomas Cuisine became aware of suspicious activity in certain employees' email accounts. Thomas Cuisine immediately began an investigation into the incident with the assistance of third-party forensic specialists. The investigation determined the employees' email accounts were accessed without authorization between January 24, 2020 and February 18, 2020.

Although the investigation was unable to determine whether personal information stored in the impacted email account had actually been viewed or removed by an unauthorized actor, Thomas Cuisine could not rule out the possibility of such activity. Therefore, in an abundance of caution, Thomas Cuisine performed a thorough and exhaustive review of the information stored within the impacted email accounts. On May 20, 2020, we determined that your personal information was present in one of the accounts.

**What Information Was Involved?** Our investigation determined that at the time of the incident your <<b2b\_text\_1(ImpactedData)>><<b2b\_text\_2(ImpactedData)>> were stored within one of the impacted email accounts and may have been subject to unauthorized access.

**What We Are Doing.** The confidentiality, privacy, and security of your personal information are among our highest priorities, and we have strict security measures in place to safeguard information in our care. Upon learning of this incident, we quickly took steps to confirm the security of our systems, including our employee email accounts. We immediately reset the passwords for the impacted email accounts and reviewed privacy policies and procedures and are working to implement additional enhanced safeguards to ensure the privacy and security of the information in our care.

As an additional precaution, Thomas Cuisine is offering you access to twelve (12) months of complementary identity monitoring services through Kroll. Details of this offer and instructions on how to activate these services are enclosed with this letter.

**What You Can Do.** You can activate the complimentary identify monitoring services we are offering. You can also review the enclosed "Steps You Can Take to Help Protect Your Information," which contains information on what you can do to better safeguard against possible misuse of your information.
