**Notice of Data Breach**

Dear <<First Name>> <<Last Name>>,

Lexington Theological Seminary (“LTS”) values its relationship with you as a former student and is committed to protecting your privacy. We are writing to you today to provide information regarding a data security incident (the “incident”) that occurred with our vendor, Blackbaud Inc. (“Blackbaud”). Blackbaud provides technological support for our administrative and academic programs at LTS. The purpose of this letter is to inform you of the contents of the data exposed during the incident and the possible effects the incident may have on your data security.

**What Happened**

On July 16, 2020, Blackbaud informed LTS that Blackbaud experienced a ransomware attack between February and May of 2020. During the attack, a cybercriminal removed a copy of a subset of data from Blackbaud’s system.\* That subset included data from LTS’s data backup file. Blackbaud investigated and concluded that no data containing credit card information, bank account information or Social Security numbers was accessed. Blackbaud informed LTS that, at most, the incident exposed students’ contact information.

The protection of your personal information is of paramount importance to us. Accordingly, LTS requested a copy of the exposed subset of data and retained a forensic firm to review and confirm the contents of the data possibly exposed. LTS’s investigation determined that the data backup file contained information about you. Furthermore, contrary to Blackbaud’s initial representations, LTS’s investigation determined that your Social Security number may have been accessed during the incident. At this time, there is no evidence to suggest that there has been any attempt to misuse information accessed during the incident. Blackbaud has informed LTS that it successfully retrieved the data, confirmed the copy was destroyed, and has no reasonable belief that the data will be misused. Blackbaud has also stated that law enforcement was involved in the investigation.

**What Information Was Involved**

Data containing your full name, social security number, date of birth, and address was involved in the incident.

**What We Are Doing**

Blackbaud is contractually required to protect the information in our database. LTS has demanded and received assurances from Blackbaud that it has corrected the vulnerability that led to the attack. Blackbaud has further represented that it is making additional security enhancements to prevent future attacks. LTS intends to closely monitor this situation and ensure

Blackbaud fulfills its security obligations. LTS is also continuing its investigation to determine the reason for Blackbaud's delay in providing notification to LTS of the incident.

Because there is reason to believe that your social security number may have been exposed during the ransomware attack on Blackbaud, we are offering identity theft protection services through ID Experts®, the data breach and recovery services expert, to provide you with MyIDCare™. MyIDCare services include: [12 months/24 months] of credit and CyberScan monitoring, a \$1,000,000 insurance reimbursement policy, and fully managed id theft recovery services. With this protection, MyIDCare will help you resolve issues if your identity is compromised.

### **What You Can Do**

We encourage you to contact ID Experts with any questions and to enroll in free MyIDCare services by calling 1-800-939-4170 or going to <https://app.myidcare.com/account-creation/protect> and using the Enrollment Code provided above. MyIDCare experts are available Monday through Friday from 6 am - 6 pm Pacific Time. Please note the deadline to enroll is January 13, 2021.

Again, at this time, there is no evidence that your information has been misused. However, we encourage you to take full advantage of this service offering. MyIDCare representatives have been fully versed on the incident and can answer questions or concerns you may have regarding protection of your personal information.

## Recommended Steps To Help Protect Your Information

- 1. Website and Enrollment.** Go to <https://app.myidcare.com/account-creation/protect> and follow the instructions for enrollment using your Enrollment Code provided at the top of the letter.
- 2. Activate the credit monitoring** provided as part of your MyIDCare membership. The monitoring included in the membership must be activated to be effective. Note: You must have established credit and access to a computer and the internet to use this service. If you need assistance, MyIDCare will be able to assist you.
- 3. Telephone.** Contact MyIDCare at 1-800-939-4170 to gain additional information about this event and speak with knowledgeable representatives about the appropriate steps to take to protect your credit identity.
- 4. Review your credit reports.** We recommend that you remain vigilant by reviewing account statements and monitoring credit reports. Under federal law, you also are entitled every 12 months to one free copy of your credit report from each of the three major credit reporting companies. To obtain a free annual credit report, go to [www.annualcreditreport.com](http://www.annualcreditreport.com) or call 1-877-322-8228. You may wish to stagger your requests so that you receive a free report by one of the three credit bureaus every four months.

If you discover any suspicious items and have enrolled in MyIDCare, notify them immediately by calling or by logging into the MyIDCare website and filing a request for help.

If you file a request for help or report suspicious activity, you will be contacted by a member of our ID Care team who will help you determine the cause of the suspicious items. In the unlikely event that you fall victim to identity theft as a consequence of this incident, you will be assigned an ID Care Specialist who will work on your behalf to identify, stop and reverse the damage quickly.

**You should also know that you have the right to file a police report if you ever experience identity fraud.** Please note that in order to file a crime report or incident report with law enforcement for identity theft, you will likely need to provide some kind of proof that you have been a victim. A police report is often required to dispute fraudulent items. You can report suspected incidents of identity theft to local law enforcement or to the Attorney General.

**5. Place Fraud Alerts** with the three credit bureaus. If you choose to place a fraud alert, we recommend you do this after activating your credit monitoring. You can place a fraud alert at one of the three major credit bureaus by phone and also via Experian's or Equifax's website. A fraud alert tells creditors to follow certain procedures, including contacting you, before they open any new accounts or change your existing accounts. For that reason, placing a fraud alert can protect you, but also may delay you when you seek to obtain credit. The contact information for all three bureaus is as follows:

It is necessary to contact only ONE of these bureaus and use only ONE of these methods. As soon as one of the three bureaus confirms your fraud alert, the others are notified to place alerts on their records as well. You will receive confirmation letters in the mail and will then be able to order all three credit reports, free of charge, for your review. An initial fraud alert will last for one year.

**Please Note: No one is allowed to place a fraud alert on your credit report except you.**

**6. Security Freeze.** By placing a security freeze, someone who fraudulently acquires your personal identifying information will not be able to use that information to open new accounts or borrow money in your name. You will need to contact the three national credit reporting bureaus listed above to place the freeze. Keep in mind that when you place the freeze, you will not be able to borrow money, obtain instant credit, or get a new credit card until you temporarily lift or permanently remove the freeze. There is no cost to freeze or unfreeze your credit files.

**7. You can obtain additional information** about the steps you can take to avoid identity theft from the following agencies. The Federal Trade Commission also encourages those who discover that their information has been misused to file a complaint with them.

Further, pursuant to the Fair Credit Reporting Act, the consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to your file is limited; you must give your consent for credit reports to be provided to employers; you may limit “prescreened” offers of credit and insurance you get based on information in your credit report; and you may seek damages from a violator. You may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
