#### RE: NOTICE OF POTENTIAL DATA BREACH

We are writing to inform you of an incident that may have impacted clients' personal information. While our investigation did not confirm that any client information was accessed or misused, we value your security and privacy and are notifying you out of an abundance of caution.

This letter contains information about what occurred and what we are doing to ensure the security of your personal data.

**What Happened?** On or before March 25, 2021, an unauthorized third party gained access to one NewSquare email account. The account may have contained client personal information that was shared in the regular course of conducting business.

**What Information Was Involved?** The account may have contained personal information including client names, Social Security numbers, and account numbers.

**How Did NewSquare Respond?** Upon discovering the incident, NewSquare promptly took steps to prevent any further access to the email account. We immediately engaged a forensic security firm to investigate and confirm the security of our email and computer systems. Upon confirming that the third party accessed the email account, we reviewed the account's contents to determine if they contained any personal information. As one of the individuals who may potentially have been affected, you are included in this notification.

We have taken additional steps to reduce the risk of this type of incident occurring in the future, including enhancing the oversight of our technical security measures.

What Resources Are We Offering? Again, at this time, there is no evidence that your personal information has been misused. However, we feel it is prudent to offer an added measure of protection for your security and peace of mind.

Although we are not aware of any instances of fraud or identity theft, we are offering a complimentary one-year membership of Experian IdentityWorks<sup>SM</sup> Credit 3B. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on immediate identification and resolution of identity theft.

IdentityWorks<sup>SM</sup> Credit 3B is being offered completely free and enrolling in this program will not hurt your credit score. **Fraud Alerts:** You may want to consider placing a fraud alert on your credit report. A fraud alert is free and will stay on your credit report for one (1) year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. To place a fraud alert on your credit report, contact any of the three national credit reporting agencies using the contact information listed above. Credit and Security Freezes: You may have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze can be placed without any charge and is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company. Since the instructions for how to establish a credit freeze differ from state to state, please contact the three major credit reporting companies as specified below to find out more information:
